Directly Via the Mobile App:

1. Download the CrowdCompass AttendeeHub App from your app store or Google Play store.

3. Select the event you are attending and click "Download".
4. Once you are in the event you are attending, click on the three line icon from the top left of the event home page and click on log in for more features.
