Students at Harrisburg High School have the opportunity to choose from multiple CTE programs and unique courses aimed at helping them explore and prepare for a variety of careers. Currently HHS offers a full range of courses in manufacturing and agricultural science. This year we also started offering medical terminology and are looking to continue to expand options for students that are interested in healthcare

related careers. In addition to our in-house course options, we also work closely with Lane and Linn Benton Community colleges through our SOAR program which provides Juniors and Seniors a chance to take college courses that we cannot offer. These earned credits can go directly towards career pathways, associate degrees, or be transferred to those attending four year universities. We also have multiple teachers that offer College-now courses which can be taken as part of their normal campus schedule. The goal is to be able to connect all of our students to post-secondary opportunities well before graduation.

The Harrisburg Middle School Robotics Club, organized and run by Elizabeth Rivas, is in the second year of existence. Ms. Rivas has done a fantastic job growing the robotics program. Initially, the robotics club started with 12 students. In order for students to be a part of the club they must fill out an application and get a reference from one of their teachers. The robotics club meets twice a week and, now, hosts approximately 20 students. Students who participate in club meetings learn how to build remote-controlled robotic cars. Each student must follow very particular instructions on how to build the car from the ground up. Students must also understand simple coding so they may program the controller to make the car go where they would like it to go. We would like to grow the program and build more complicated robots and travel to different competitions around the Willamette Valley.

Leaving a Legacy in Helix

The Helix School District has been able to accomplish so much since our voters approved two GO bonds (2008 and 2012), during my tenure as the superintendent at Helix . These were the first bonds passed in the Helix SD since 1957. The upgrade, in part, included remodeling our 1923 high school (see right) and the addition of two classrooms (HS Science and HS Business/Computers). We were also able to add two classrooms to our elementary building (Kindergarten and Sped Resource Rm.). In addition, the bonds allowed Helix to build a new gym (see right), weight room, remodeled our main gym, upgraded our technology infrastructure and replaced the old boiler heating system with a computer controlled HVAC system throughout our district.

I have treasured my 27 years spent in the Helix SD. I was a full-time teacher for 13 years (HS Social Studies, 4-12 PE), then took on the superintendent position 14 years ago. Most people may not know Helix has only one administrator, which is why I have really relied on networking with the IMESD regional superintendents.

I have really enjoyed my experience at Helix and I'm fortunate to have all three of my children attend Helix from K-12th grade and graduate from Griswold HS. I will miss Helix, but look forward to the next chapter of my professional career as the Director of Facilities and Operation at the IMESD.
