Policy and Advocacy Update

We want to thank all of the superintendents and administrators around the state who are engaging in our COSA workgroup process. Your input and feedback are critical to develop our policy and advocacy priorities for 2025. Our Policy and Advocacy team organized two penultimate COSA workgroup meetings on August 22 this year. Our COSA Funding Workgroup is working on specific recommendations around current service level, special education funding, and facilities. And our COSA Student Supports Workgroup is developing key policy platforms and goals that will inform our legislative priorities and education coalition work. Top issues include: Student Mental Behavioral Health, Special Education, Summer Learning, Early Literacy, and Workforce. Our final formal workgroup meetings will take place this September. As we continue to finalize our priorities, our team will provide more updates at our upcoming September Statewide Off-the-Record Meeting, and our 2024 Fall Regional Meetings.
