The School District





The Junction City School District serves more than 1500 students in two elementary schools, one middle school and one high school. The district employs a staff of 100 licensed employees, 101 classified employees, 13 confidential employees and 11 administrators. It has a general fund budget of about \$24 million and passed a \$14.6 million bond in 2016.

Junction City offers districtwide AVID and career and technical education courses at the middle and high schools. Junction City High School also offers a culinary arts program, FFA, SkillsUSA and College Now courses. In addition, the district has Junction City Options, a program that students can do fully or partially online.
