The School District



The **Lake County School District** serves approximately 690 students in three elementary schools and one combination middle school/high school. The district started this year the Evergreen Charter School online or hybrid option.

The Lake County School District has a general fund budget of about \$12.8 million. The district employs a staff of 46 licensed employees, 50 classified employees, 5 confidential employees and 7 administrators.

The Lake County School District boundaries cover nearly 2,000 square miles, and the district is the largest of five districts in Lake County. It offers a full array of student programs and works with Klamath Community College to offer higher education possibilities. Students who attend all four years at a Lake County high school are eligible for the Collins-McDonald and the Bernard Daly Fund scholarships.

The Lake County School District is centered in southeast Oregon's Lakeview, the Lake County seat. **Lakeview**, a community of about 2,200 residents, calls itself "Oregon's Tallest Town" because of its 4,798-foot elevation. The local economy runs on agricultural, lumber and government work. Nearby features including Goose Lake, the Warner Mountains, the Hart Mountain Antelope Refuge and Hunter's Hot Springs draw tourists as well as areas for rock hunting and hang gliding.
