Position: English Language Arts Intervention TOSA (SHS)

JOB DEFINITION:

The English Language Arts Intervention TOSA, under general supervision of the principal, facilitates and coordinates the implementation of an English Language Arts academic support program for grades 9-12. This position will directly instruct students addressing instructional needs. It is essential that the instructional methods take into account the impact of the COVID-19 pandemic, understanding the importance of student motivation. The selected candidate will need to re-engage students in the learning process, providing the support necessary for credit completion.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Designing and implementing an academic support program for students in grades 9-12.
- Assess and monitor student progress, create data reports to share with staff, parents and the community.
- Work collaboratively with teachers and school-wide teams to improve students' knowledge and skills for English Language Arts.
- Knowledge of instructional strategies aligned with student assessment results. Able to adjust strategies based on the changing needs of students.
- Engage in ongoing professional growth to stay current in new developments in the field of literacy.
- Demonstrated successful leadership at a building or district level in the area of literacy instruction.
- Broad, strong knowledge of multi-tiered systems of support.
- Ability to conduct and evaluate instructional methods, using results to build continuous improvement into the intervention program.
- Organizational skills to manage multiple projects, prioritize work, keep and maintain accurate records, meet deadlines.
- Demonstrated ability to creatively solve challenging problems through innovation and collaboration
- Collaborate with teacher teams to establish a common language, common understanding of grade level expectations, rubric development and use, and common assessments.
- Work with school improvement leadership teams to help coordinate improvement plans that have research-based practices related to effective English Language Arts instruction.
- Evaluates and reflects upon professional practices and current research to support student learning.

- Valid Oregon Teaching License with appropriate endorsement.
- Three (3) years successful teaching experience of secondary English Language Arts.
- Knowledge of literacy instruction to students, reading interventions, assessments, and monitoring student progress.

While performing the duties of this job, the employee will occasionally sit, walk or stand. The employee will occasionally reach forward or above the head more than the average person.
