School Resource Officer

- What is an SRO?
 - Certified Law Enforcement Officer
 - At least 3 years experience
 - Assignment length depends on department



School Resource Officer

- What an SRO does
 - Criminal Investigations
 - Assist Administration with other investigations
 - Teaching
 - (DARE, GREAT, Law Related Education, Cyberbullying, Bullying, Drug/Alcohol classes, Sexting, Etc.)
 - School Safety
 - Community Safety
 - Problem Solving
 - Etc.

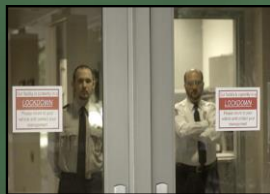
Lockdown: What Is Its Purpose?



The purpose of a Lockdown is to secure staff, students, and visitors into the nearest secured facility and minimize their exposure to a potential threat and/or to allow them other survivable options such as evacuation, hiding, running, crawling, playing dead, speaking or fighting for their life if necessary, during a potentially lethal threat situation. The Lockdown plan, when implemented, serves to minimize the risk of injury or death to students, staff, faculty and any visitors who are on campus at the time of the threat.

Modified Lockdown

- A modified Lockdown can be utilized when the threat is known to be outside your buildings or property but possibly heading your way
- Doors stay locked and blinds shut but work continues as usual until an all clear is called
- AKA a Limited or Targeted Lockdown



Modified Lockdown

- This type of Lockdown can be called in to the institution by security personnel or someone in the law enforcement field
- Because the threat is of lesser concern, officers can be posted outside of the effected area of the campus to deter the potential threat
- Should stay in contact with local law enforcement if they warned you of the potential threat



Examples of When a Lockdown Might Occur

- Threats to Student/Staff/property
- Police in area looking for a crime suspect
- Violent crime near your workplace



Examples of When a Lockdown Might Occur

- Reported weapon in the workplace
- An active workplace shooting
- Your plan should cover the best and worse case scenario
- NIU Active Killer Training "Saved lives"



How Can Technology Simplify L/D Implementation?

- Automated announcement
- Activated remotely or by switch
- Staff may activate if necessary
- Will eliminate the need for the P.A. to be "manned" continuously which allows more bodies to implement your plan.
- How did staff alert staff and students at Sandy Hook?



How Can Technology Simplify L/D Implementation?

- The combination of three tones followed by the announcement repeatedly will eventually capture everyone's attention
- Allows the Lockdown announcement to continue for a pre-set time
 - Anyone trying to enter the school after the initial announcement will know what is happening
- Don't be afraid to state that the police have been called and are en route to the school in your Lockdown announcement
- Allows for everyone to start locking down immediately!
 - A true immediate notification system

Lockdown Announcement

• Stage One

"Staff, this is a Lockdown. Initiate your Lockdown procedures immediately. Be advised that law enforcement has been notified. If you are a visitor outside the building, please leave the property immediately, and call 911."

- Update the location manually when possible to do so

Lockdown Announcement

• Stage Two

"Staff, this Lockdown incident is now secure. The buildings are now secure but please stay in your rooms pending an all-clear notification."

Lockdown Announcement

• Stage Three (used for modified lockdown only)

"Staff, this Lockdown is now all-clear. I repeat, this Lockdown is all-clear. Please have all students return to their home rooms for a roll-call. An announcement will be made shortly to provide staff and students with an update on this Lockdown. Thank you, and congratulations to everyone for doing such a great job on implementing our lockdown plan."

Considerations for a Lockdown Plan

What do you do if, during your Lockdown plan, the fire alarm is activated?

If it is a real Lockdown then it supersedes the fire drill unless smoke or fire is reported

Give an intruder description if possible



Is Your Institution NIMS Trained?

- Courses taught by the Office of Homeland Security
- Through the Department of Emergency Management
- This is required training if you are receiving any kind of Federal grant \$'s
- Presidential Directive #5 allows for Federal reimbursement

Is Your Institution NIMS Trained?

- Remember that once Police/Fire departments are on scene they take over
- You need to speak the same language
 - ICS
 - EOC
 - Unified Command
 - F.L.O.P.

Other Planning Considerations: Students

- Prepare the students with a Lockdown explanation video
- Offer student training sessions so that accurate information can be presented regarding your plan
- Teach them realistic survival options
- Answer their questions truthfully and realistically!
 - Based on actual events

Students

- Use student observers during the Lockdown drill
- Empower the students with their participation!
- Remind students to report threats against their school or against students/staff/faculty

Parent Considerations

- Parents need to know that your school has a Lockdown plan
 - Many parents are now asking schools if they have one
- More books are being published educating parents about this subject
 - "Staff, This is a Lockdown!" by Jesus Villahermosa
 - School Shootings- What Every Parent and Educator Needs to Know to Protect Our Children
- You must educate them where to respond should a worse case scenario occur or else they will respond to your school!
